Terms and Conditions for E-Auction

1. The sale will be done through E-Auction platform provided at the Website <https://www.ebkray.in> on 18.10.2024 (from 04:00 PM to 06:00 PM). The intending bidders/purchasers are requested to register on portal (<https://www.ebkray.in>) using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider, the intending Bidders/ Purchasers has to transfer the EMD amount using online mode in his/ her EMD wallet. In case EMD amount is not available in EMD wallet, system will not allow to bid. The registration, verification of KYC documents and transfer of EMD in wallet must be completed well in advance, before auction. Only after having sufficient EMD in his/ her wallet, the interested bidder will be able to bid on the date of e-auction.
2. It shall be the responsibility of the bidders to inspect and satisfy themselves about the assets and specification before submitting the bid. The inspection of the machineries put on auction will be permitted to interested bidders at sites on **14.10.2024** between 11:00 AM to 01:00 PM. List of the machineries appended hereunder at the end of the terms & conditions.
3. Earnest Money Deposit (EMD) amount as mentioned above shall be paid through online mode i.e. NEFT/RTGS/ Transfer on portal (<https://www.ebkray.in>) in bidders EMD wallet which shall start from 14.10.2024 (01:00 PM) to 18.10.2024 (06:00 PM). EMD by any other mode such as Cheque etc. will not be accepted. Bidders, not depositing the required EMD in his/her wallet, will not be allowed to participate in the e-auction. The earnest money deposited shall not bear any interest. The EMD of the unsuccessful bidders will be returned/released without interest.
4. The intending bidders/ purchasers are required to participate in the e-auction process at e-auction service provider's website on portal <https://www.ebkray.in>. The sale notice containing the General Terms and Conditions of sale is available/ displayed in the Banks website/webpage portal <https://www.centralbankofindia.co.in> and <https://www.ebkray.in>. The intending participants of e-auction may download free of cost, copies of sale notice, terms and conditions of e-auction and help manual on the operational part of e-auction related to this e-auction from the portal <https://www.ebkray.in>
5. Machineries shall be sold only above the reserve price and that even if there is only one participant, he/she will have to make one increase to signify his/her offer for such price i.e. the price equal to reserve price plus the amount equal to one increase as specified in the sale notice. If any bidder/ the sole bidder/ bidders does not/ do not make even one increase, the machineries shall not stand auctioned for the reserve price. The bid quoted below the reserve price shall be rejected. The bidders shall increase their bids in multiples of the amount specified in the sale notice. Unlimited extensions of 10 minutes time will be given in case of receipt of bid in last ten minutes. Ten minutes time will be allowed to bidders to quote successive higher bid and if no higher bid is offered by any bidder after the expiry of ten minutes to the last highest bid, the e-auction shall be closed.



6. Intending bidders are advised to properly read the sale notice, terms and conditions of e-auction and help manual on the operational part of e-auction and follow them strictly.
7. In case of any difficulty or assistance is required before or during e-auction process, they may contact authorized representative of our e-auction service provider (<https://www.ebkray.in>), details of which are available on e-Auction portal.
8. The successful bidder shall have to deposit 25% of the bid amount (including 10% of reserve price as EMD amount, which will be deducted from his/her EMD Wallet), immediately on the same day but not later than next day (In case next day is a holiday, payment should be made within the next working day) through NEFT/RTGS in the account **No. 3778578780, Name - Bill Pay Account, IFSC – CBIN0280412 (Central Bank Of India, Sector 17B Branch, Chandigarh)**. Further, the balance amount being 75% of entire bid amount shall be paid within 15 days from the date of confirmation of sale (subject to approval of the bid by the Bank). In case of failure to deposit the due amounts as above by the scheduled dates/time, sale shall be cancelled and any amount deposited by the successful bidder will be forfeited and the Bank shall have the liberty to conduct a fresh auction/ sale of machineries & the defaulting bidder shall not have any claim over the forfeited amount and the machineries.
9. Default in payment of 25% of bid amount (including 10% of reserve price as EMD amount, which will be deducted from his/her EMD Wallet), immediately on the same day but not later than next day (In case next day is a holiday, then within the next working day) as stated above and / or 75% of the entire bid amount within 15 days, sale shall be cancelled and any amount deposited by the successful bidder will be forfeited.
10. Payment of sale consideration by the successful bidder to the Bank will be subject to TDS under section 194-IA of Income Tax Act 1961 and TDS is to be paid/borne by the successful bidder at the time of deposit of remaining 75% of the bid amount.
11. On receipt of entire sale consideration, the Bank shall issue the Sale Certificate as per the rules. The purchaser shall bear the stamp duties, including those of sale certificate, registration charges, all statutory dues payable to Government/ any authority, Taxes, GST both existing and future relating to machineries.
12. No request for inclusion/ substitution of names, other than those mentioned in the bid, in the sale certificate will be entertained. The sale certificate will be issued only in the name of successful bidder.
13. The sale certificate will not be issued in case of any stay/ injunction/ restraint order passed by the DRT/ DRAT/ High Court or any other court against the issue of sale certificate. Further, no interest will be paid on the amount deposited during this period. The deposit made by the successful bidder, pending execution of sale certificate, will be kept in non-interest bearing deposit account. No request for return of deposit either in part or full for cancellation of sale will be entertained. In case of stay of further proceedings by DRT/DRAT/High Court or any other court, the auction may either be deferred or cancelled and persons participating in the sale shall have no right to claim damages, compensation or cost for such postponement or cancellation.
