#### TERMS AND CONDITIONS OF E-AUCTION/A/C DHARMICHAND GURJAR BIJAINAGAR

1. The sale will be done by the undersigned through E-Auction platform provided at the Website <https://www.ebkray.in> on 04/12/2024 (from 12:00 PM to 4:00 PM). The intending bidders/purchasers are requested to register on portal (<https://www.ebkray.in>) using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider, the intending Bidders/ Purchasers has to transfer the EMD amount using online mode in his EMD wallet. In case EMD amount is not available in EMD wallet, system will not allow to bid. The registration, verification of KYC documents and transfer of EMD in wallet must be completed well in advance, before auction. Only after having sufficient EMD in his wallet, the interested bidder will be able to bid on the date of e-auction. In case of offers for more than one property, bidders will have to deposit EMD for each property separately.
2. It shall be the responsibility of the bidders to inspect and satisfy themselves about the assets and specification before submitting the bid. The inspection of the property/ies put on auction, will be permitted to interested bidders at sites on 01/11/2024 TO 02/12/2024 between 10:00 AM to 12:00 PM.
3. Earnest Money Deposit (EMD) amount as mentioned above shall be paid through online mode i.e. NEFT/RTGS/ Transfer on portal (<https://www.ebkray.in>) in bidders EMD wallet which shall be start from 01/11/2024 (10:00 AM) to 03/12/2024 (06:00 PM). EMD by any other mode such as Cheque etc. will not be accepted. Bidders, not depositing the required EMD in his wallet, will not be allowed to participate in the e-auction. The earnest money deposited shall not bear any interest. The EMD of the unsuccessful bidders will be returned/released without interest.

8. The successful bidder shall have to deposit 25% of the bid amount (including 10% of reserve price as EMD amount, which will be deducted from his/her Global EMD Wallet), immediately on the same day but not later than next day (In case next day is a holiday, payment should be made within the next working day) through NEFT/RTGS in the account No.3895783852, Name – Earnest Money Deposit Bijainagar, IFSC –CBIN0280438 (BIJAINAGAR). Further, the balance amount being 75% of entire bid amount shall be paid within 15 days from the date of confirmation of sale (subject to approval of the bid by the Authorized Officer). In case of failure to deposit the due amounts as above by the scheduled dates/time, sale shall be cancelled and any amount deposited by the successful bidder will be forfeited and the Authorized Officer shall have the liberty to conduct a fresh auction/ sale of property & the defaulting bidder shall not have any claim over the forfeited amount and the property.
