## TERMS AND CONDITIONS OF E-AUCTION/A/C

- 1. The sale will be done by the undersigned through E-Auction platform provided at the Website <a href="https://www.ebkray.in">https://www.ebkray.in</a> on 29/11/2024 (from 12:00 PM to 4:00 PM). The intending bidders/purchasers are requested to register on portal (<a href="https://www.ebkray.in">https://www.ebkray.in</a>) using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider, the intending Bidders/ Purchasers has to transfer the EMD amount using online mode in his EMD wallet. In case EMD amount is not available in EMD wallet, system will not allow to bid. The registration, verification of KYC documents and transfer of EMD in wallet must be completed well in advance, before auction. Only after having sufficient EMD in his wallet, the interested bidder will be able to bid on the date of e-auction. In case of offers for more than one property, bidders will have to deposit EMD for each property separately.
