The auction will be "Online E-auction" through *e-bkray portal*

- 1. Date and Time for auction: 24.07.2025 between 04:00 PM To 05.00 PM (With auto extension clauses in case of bid in last 5 minutes before closing). E-Auction is being held on "As is where is", "As is what is" and "Whatever there is" basis.
- Auction/Bidding shall only through "Online Electronic Bidding" through the website / portal <u>e-bkray</u> and property details is also available at <u>e-bkray</u>. Bidders are advised to go through the website for detailed terms and part in the e-auction sale proceedings.
- Bidders has to complete following formalities well in advance:-Step 1- Bidder/ Purchaser Registration: Bidder to register on e-Auction portal <u>e-bkray- PSB</u> <u>Alliance</u> using his mobile number and email-id. Step 2: KYC Verification: Bidder to upload requisite KYC documents. KYC documents shall be verified by e-auction service provider (may take 2 working days) Step 3: Transfer of EMD amount to his Global EMD Wallet: Online/ off-line transfer of fund using NEFT/Transfer, using challan generated on e-Auction portal. Step 1 to Step 3 should be completed by bidder well in advance, before e-Auction date.
