3. Tendering shall be conducted in accordance with Open Tender procedures of the Bank.

4. For general public, bids must be accompanied by **Cost of Tender Document of Rs. 500/-** as Demand Draft in favour of Central Bank of India, Regional Office, Bhopal, payable at Bhopal. Cost of Tender Document is not applicable for the Staff and retired Staff members of the Bank. **Any bid from General public not accompanied with the Cost of Tender Document will be rejected. Cost of tender is not returnable.**

5. For general public, bids must be accompanied by **Earnest Money Deposit (EMD) of Rs. 10,000/-** as Demand Draft in favour of Central Bank of India, Regional Office, Bhopal, payable at Bhopal. For Staff and retired Staff members of the Bank, the bids must be accompanied by Earnest Money Deposit (EMD) of Rs. 5000/-. **Bids without EMD will be rejected.**

7. The vehicle identified for sale may be inspected by prospective bidders with permission of Security Department from 06 March 2024 to 21 March 2024 during Bank's working hours at our Regional Office Bhopal Office Premise with address mentioned above.

8. The bid should be submitted in a **sealed envelope** with superscription "**Bid for Purchase of Vehicle No. MP 04 CJ 9721**"

9. The bid along with prescribed documents should be submitted before from 06 March 2024 to 21 March 2024 till **5:00 PM to Regional Office, Bhopal, 9 Arera Hills Bhopal**. Tender offers will be opened by the committee comprising at least three officers headed by Chief Manager at 3:30 PM on **21 March 2024** and at the address mentioned above in the presence of the bidders' representatives who choose to attend.

10. The offer submitted should have a validity of 90 Days from the bid opening date.
11. The successful bidder has to pay the full amount for the vehicle less amount of EMD **within seven working** days from the date of receipt of intimation by means of DD in favour of Central Bank of India, Regional Office, Bhopal, payable at Bhopal. Failure to make payment of the full amount in time may result in forfeiture of the offer to purchase the vehicle as well as the EMD submitted.
12. In case of no response from H 1 bidder or if the H 1 bidder refuses to accept the vehicle due to any reason, the EMD shall be forfeited and offer will be extended to the H 2 bidder (H 2 to match the rate of H 1). Similar procedure shall be followed in respect of H3, H4 etc. as long as the Bank is able to get a price above the Reserve Price. **The Reserve Price is Rs. 70,000/-.** Vehicle shall not be disposed below the Reserve Price.
13. The sold vehicle will be delivered only after the transfer of registration to the name of purchaser and his/her name is updated in the records of Registrar of Vehicles as the new owner and after verification of KYC documents of the purchaser by the Bank. Format for submission of Application is attached as Annexure A with this tender document. The Bidder must submit the documents required to be submitted along with the bid to avoid rejection of application.
14. The sold vehicle shall have to be removed by the successful bidder at his own expenses.
15. The successful bidder will be responsible for getting the Registration Certificate of the vehicle transferred in his name and at his cost expeditiously. Photo copy of the RC & related documents should be given to the Bank before taking possession of the vehicle.
16. Approval of sale offer is subject to Bank's internal procedure and as such participating bidders have no right to claim interest on the Earnest Money deposited by them with the bid/quotation/sale offers.
17. **The Bidder has to sign each page of all the offer papers being submitted.**
18. Bank will be discharged from its liability from the date of sale of vehicle.
19. In case of any dispute, jurisdiction will be restricted to Bhopal only.
