- 5. For general public, bids must be accompanied by Earnest Money Deposit (EMD) of Rs. 10,000/- as Demand Draft in favour of Central Bank of India, Regional Office, Sagar, payable at Sagar. For Staff and retired Staff members of the Bank, the bids must be accompanied by Earnest Money Deposit (EMD) of Rs. 5000/-. Bids without EMD will be rejected.

The bid along with prescribed documents should be submitted from 21 June 2024 to 06 July 2024 till 3:30 **PM to Regional Office,** 7 University Road, Sagar Tender offers will be opened by the committee comprising at least three officers headed by Chief Manager at 5:00 **PM on 06 July 2024** and at the address mentioned above in the presence of the bidders' representatives who choose to attend.
- 10. The offer submitted should have a validity of 90 Days from the bid opening date.
- 11. The successful bidder has to pay the full amount for the vehicle less amount of EMD within seven working days from the date of receipt of intimation by means of DD in favour of Central Bank of India, Regional Office, Sagar, payable at Sagar. Failure to make payment of the full amount in time may result in forfeiture of the offer to purchase the vehicle as well as the EMD submitted.

In case of no response from H 1 bidder or if the H 1 bidder refuses to accept the vehicle due to any reason, the EMD shall be forfeited and offer will be extended to the H 2 bidder (H 2 to match the rate of H 1).
