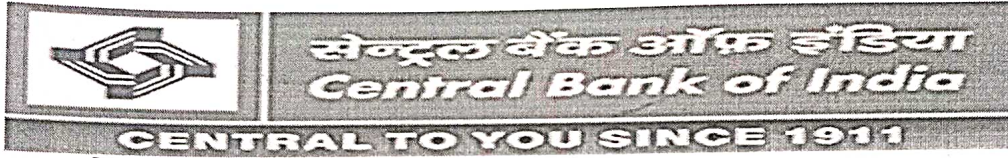

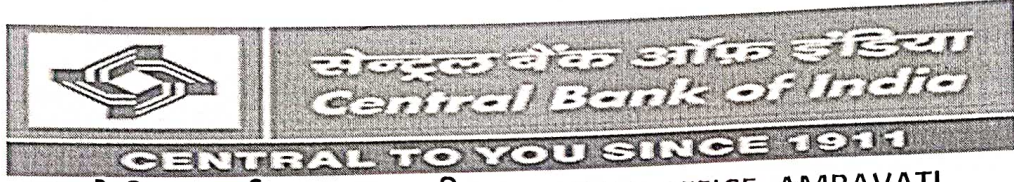

5. All the application received will be placed and opened before the Scrutiny committee on **20/06/2024 at 16.00hrs. (Tentatively)**. Bank can change the time and date without notice. The purchaser may send their representative during opening time. No separate notice/information will be given for opening.
