- 3. **Opening of Tenders & Validity Period**: The bids are to be submitted within the specified Date & Time. The interested tenderers may remain present during the offer opening process at the scheduled date and time. The offer will be valid for a period of two months from the date of receipt of offer by successful bidder to enable the office for observing all necessary formalities.
- 4. **Inspection of Vehicle**: It shall be the responsibility of the bidder to inspect and satisfy themselves about the vehicle before submitting the bid. Vehicles are available for examination/inspection with permission of the Central Bank of India, Zonal Office, Pune, at the mentioned address in Para 2 on any Bank's Working Day **between 11:00 AM to 14:00 PM from 22.07.2024 to 12.08.2024.**
- 5. Submitted Bid must be super scribed as "BID FOR PURCHASE OF VEHICLE". Registration No. e.g (MH-12 NJ-3284). BID WOULD BE EXCLUDING GST. GST would be paid by the buyer. For one car only one bid will be accepted.
- 6. The Bidder sending their Bids through post must ensure that the bids remain physically intact and is submitted as per the Tender requirement. Bank will not be responsible for any loss/damage/tampering during transit.
- 7. Earnest Money Deposit (EMD): EMD of the following amount has to be paid along with the offer:
  - ₹ 10,000/- (Rupees Ten Thousand Only) per vehicle for General Public
  - ₹ 5,000/- (Rupees Five Thousand Only) for Staff and Ex-staff
- 8. The DD for application (as mentioned in Para 1 above) and EMD must be enclosed with the Bid. The successful bidder has to pay the FULL AMOUNT PLUS THE GST APPLICABLE FOR VEHICLE within Seven days from the date of receipt of intimation (Excluding the date of intimation) by means of DD favouring Central Bank of India and payable at Pune. Failure to make payment of the full amount in time may result in forfeiture of the offer to purchase the vehicle as well as the EMD submitted. **Application forms without APPLICATION FEE and EMD will be rejected**. Presence of respondents during the opening of the tender on the appointed date and time will be allowed and they will be informed about the same through Letter/ Email.
- 9. Bids below 'Reserve Price' will not be considered. The 'Reserve Price' will be declared at the time of opening of the Bids. In case of no response from the H1 bidder or if the H1 bidder refuses to accept the vehicle bid due to any reason, the H1 bidder's EMD shall be forfeited and offer will be extended to H2 bidder (H2 has to match the rate of H1). Similar procedure shall be followed in respect

of H2/H3 etc. as long as the Bank is able to get a price above the Reserve Price. Vehicle shall not be disposed off below the Reserve Price.

#### a. Bids below the Reserve Price will not be accepted.

- b. The offer must be valid for a period of 60 days from the last date of receipt of bids.
- c. No tender document will be accepted after the expiry of stipulated date and time for the purpose under any circumstances whatsoever.
- d. The successful bidder will be required to deposit the balance bid amount after deducting the Earnest Money Deposit as mentioned above.
- e. The vehicle sold will be handed over only after the completion of the RTO formalities by the buyer. This will include transfer of the registration to the purchaser and appearance of his/ her name on the NOC as the new owner and verification of KYC documents by Bank. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously.
- f. Transfer of Insurance in the name of the successful bidder will also have to be ensured. Existing Insurance will be transferred to the Buyer based upon pro-rata basis (proportionate balance premium will be recovered from the successful bidder).
- g. Formats for submission of "Personal Particulars" and the "Bid" are attached as Annexure 'A' & 'B' respectively with this tender notice. The Bidder must submit the documents required to be submitted along with the bid to avoid rejection of the application.
