Ref: Tender for Pest Control Services through GeM Portal vide Bid No. GEM/2024/B/5267855 dated 19 Aug 2024.


1. A Pre-bid meeting for Pest Control was held on **28 Aug 2024**. Following officials from the Bank and the representatives of the firms attended the meeting:-
