- 3. **OPENING OF TENDERS & VALIDITY PERIOD:** Starting date of Tender from **02 Jul 2025**. The bids are to be submitted by **1400 H on 22 Jul 2025**. The interested tenderers may remain present during the offer opening process at the scheduled date and time.
- 4. **INSPECTION OF VEHICLE:** It shall be the responsibility of the bidder to inspect and satisfy themselves about the vehicle before submitting the bid. Vehicle is available for examination/inspection with permission of the Central Bank of India, Central Office, Mumbai, at the below mentioned address on any Bank's Working Day **between 11:00 AM to 14:00 PM from 02.07.2025 to 22.07.2025: -**

- 5. SUBMITTED BID MUST BE SUPER SCRIBED AS "BID FOR PURCHASE OF VEHICLE". REGISTRATION NO. e.g (MH-01-BY-7553). BID WOULD BE EXCLUDING GST. GST WOULD BE PAID BY THE BUYER. FOR ONE CAR ONLY ONE BID WILL BE ACCEPTED. FOR MORE THAN ONE CAR A SEPARATE BID MUST BE SUBMITTED FOR EACH CAR WITH EACH BID BEING ACCOMPANIED WITH SUPPORTING EMD ENCLOSED IN A SEPARATE ENVELOPE.
- 6. THE BIDDER SENDING THEIR BIDS THROUGH POST MUST ENSURE THAT THE BIDS REMAIN PHYSICALLY INTACT AND IS SUBMITTED AS PER THE TENDER REQUIREMENT. BANK WILL NOT BE RESPONSIBLE FOR ANY LOSS/DAMAGE/TAMPERING DURING TRANSIT. The bids should be super scribed as per para 5 above.
- 7. Earnest Money Deposit of ₹ 10,000/- (Rupees Ten Thousand Only) per vehicle for General Public and ₹ 5,000/- (Rupees Five Thousand Only) for Staff and Ex-staff shall be paid along with the offer in the form of Account Payee Demand Draft drawn in the favour of Central Bank of India and payable at Mumbai, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from a Nationalized/ Scheduled Bank located in

India, OTHER THAN CENTRAL BANK OF INDIA and EMD(s) must be enclosed with EACH Bid. The successful bidder has to pay the FULL AMOUNT PLUS GST APPLICABLE FOR VEHICLE WITHIN SEVEN DAYS from the date of receipt of intimation (Excluding the date of intimation) by means of DD / Pay Order favouring Central Bank of India and payable at Mumbai. Failure to make payment in full will result in forfeiture of the offer and the EMD submitted. Application forms without Application Fee or EMD will be rejected. Presence of respondents during the opening of the Tender on the appointed date and time will be allowed and they will be informed about the same through Letter /email.

8. In case of no response from H1 bidder or if the H1 bidder refuses to accept the vehicle bid for due to any reason, the EMD shall be forfeited and offer will be extended to H2 bidder (H2 to match the rate of H1). Similar procedure shall be followed in respect of H2 / H3 etc. as long as the Bank is able to get a price above the Reserve Price. Vehicle shall not be disposed-off below the Reserve Price.

9. Terms and conditions:

- a) RESERVE PRICE HAS BEEN FIXED IN ACCORDANCE WITH THE BANKS POLICY AND WILL BE CONFIDENTIAL.
- b) Bids below the Reserve Price will not be accepted.
- c) The offer must be valid for a period of 60 days from the last date of receipt of bids.
- d) No tender document will be accepted after the expiry of stipulated date and time for the purpose under any circumstances whatsoever.
- e) **Earnest Money Deposit** will be returned to the successful bidder post payment of the bid amount.
- f) THE DELIVERY OF THE SOLD VEHICLE WILL BE GIVEN ONLY AFTER THE COMPLETION OF RTO FORMALITIES BY THE BUYER (I.E. TRANSFER OF NAME IN REGISTRATION CERTIFICATE OF THE RESPECTIVE VEHICLE). GST would be paid by the successful bidder. Existing Insurance will be transferred to the Buyer based upon pro-rata basis (proportionate balance premium will be recovered from the successful bidder). Format for submission of "Personal Particulars" and the "Bid" is attached as Annexure A & B respectively with this Tender Notice.
- g) The sold vehicle shall have to be removed by the successful bidder within 10 days from the Date of Transfer of Ownership (**REFLECTION OF NAME ON RC**) at his own expense.
- h) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously.
- i) Approval of Sale offer is subject to Bank's internal procedure and as such participating bidders have no right to claim interest on the Earnest Money deposited by them with the Bid/ Quotation/ sale offer.
- j) The Bidder has to sign each page of the Tender being submitted.
- k) The Bank (Central Bank of India) reserves the right to accept / reject the bid(s) and/or scrap the tender without assigning any reason therefor and all the bidders will be intimated about such a development on the Contact Details provided.
