CORRIGENDUM

Engagement of Chief Information Security Officer (CISO) On Contractual Basis

Attention is invited to Notification dated 16.12.2024, whereby applications were invited for “Engagement of Chief Information Security Officer (CISO) On Contractual Basis” and closing date for online registration of application was 29.12.2024.

Now it has been decided by the Bank to revise the eligibility criteria for the above-mentioned post. The revised eligibility criteria are as under:

<p>Minimum Qualification- Professional's qualification should be Full-time master's degree in engineering disciplines preferably Computer Science / Information Technology / Electronics & Telecommunications / Electronics & Electrical / Electronics & Communication or Master's in computer application from a University/ Institute recognized by Government of India or its Regulatory bodies.</p> <p>Mandatory: - Applicants possessing Security Certifications like CISSP (Certified information Systems Security Professional / CISM (Certified Information Security Manager) / CISA (Certified information Systems Auditor) would be preferred.</p>	<p>Minimum Qualification - Professional's qualification should be bachelor's degree in engineering disciplines preferably Computer Science / Information Technology / Electronics & Telecommunications / Electronics & Electrical / Electronics & Communication or Master's in computer application or M.Sc. in Computer Science from a University/ Institute recognized by Government of India or its Regulatory bodies.</p> <p>Mandatory: - Applicants should possess one of the Security Certifications like CISSP (Certified information Systems Security Professional / CISM (Certified Information Security Manager) / CISA (Certified information Systems Auditor).</p>
<p>Age Limit - Professional's age should be Minimum - 40 years & Maximum - 50 years, as on 30.11.2024.</p>	<p>Age Limit - There will not be any minimum age criteria, however the upper age should not be more than 55 years as on 30.11.2024.</p>

<p>Minimum Experience – Professional’s minimum experience should be of 15 years post qualification experience in Information Technology/Information Security of which at least 2 years should be in the domain area Information Security in senior/top management cadre (DGM/AGM or equivalent) in Banks/BFSI/Fintech. Candidates who have worked as CISO would be preferred.</p>	<p>Minimum Experience – Professional’s minimum experience should be of 12 years post qualification experience in Information Technology/Information Security of which at least 2 years should be in the domain area Information Security in senior/top management cadre (DGM/AGM or equivalent) in Banks/BFSI/Fintech/Large Corporates. Candidates who have worked as CISO would be preferred.</p>

The cut-off date for ascertaining eligibility regarding age, educational qualification and work experience is 30.11.2024.

Please note candidates who have applied earlier and are fulfilling the revised eligibility criteria need not to apply afresh.

All other terms of our notification dated 16.12.2024 remains unchanged.
