- Attention is drawn to notification dated 27.02.2023 **informing about conducting of Written examination for the post of 50 vacancies of Chief Managers and 200 vacancies for the post of Senior Managers in Mainstream in our Bank, wherein the date of written examination conducted by IBPS was 04<sup>th</sup> March 2023 (Saturday).**

**DECLARATION OF WRITTEN EXAMINATION RESULT**

Based on the written examination conducted by IBPS for recruitment to the post of Chief Managers and Senior Managers in Mainstream in our Bank we are pleased to declare the list of candidates who have qualified the written examination conducted on 04.03.2023 and are called for preliminary interview to be conducted by Bank at designated centres.

The list of Centers is as per attached Annexure and the procedure for selection of center for interview will be notified shortly.

**Tentative date for commencement of Preliminary interview is 22.05.2023.**

On completion of preliminary round of interview shortlisted candidate upto 4 times the number of vacancies shall be called for final stage of interview, based on merit of marks in interview only. This will not include written marks. The interview shall be conducted for 100 marks for both stages of interview. The qualifying marks for both the stages of interview shall be 50% for general candidates and 45% for SC/ST/OBC/PWD candidates.

Candidates are advised to regularly visit the Bank's website for updates/ notices/ instructions. All announcements/addendum/ corrigendum/ details pertaining to this process will be only published / provided on authorized Bank's website [www.centralbankofindia.co.in](http://www.centralbankofindia.co.in) from time to time under Career section. No separate communication/ intimation will be sent to the candidates who are not selected/ shortlisted in the process. All notification/ communication placed on Banks's website shall be treated as intimation to all candidates who have applied for the process.

Merely satisfying the eligibility criteria norm does not entitle the candidate to be called for GD/Interview/Selection process. The Bank reserves the right to call only the requisite number of candidates for GD/Interview/Selection process after preliminary screening/ shortlisting with preference to the candidates' age, qualification, essential requirements, suitability etc.

The Bank reserves the right to reject any application/ candidature at any stage or cancel the conduct of interview/GD or to cancel the recruitment process entirely at any stage without assigning any reason.
