

Terms & Conditions :-

1. Vehicle will be available for inspection between 10.00 am to 05.00 pm during working days w.e.f. 05/08/2024 to 16/08/2024 at Regional Office, First Floor, BSNL Building, Opp: Jail Road, Near Kuber Bhavan, Vadodara - 390 001.
2. Bidder should send their bid in a sealed envelope with a DD of Rs. 5000/- for Staff/Ex-Staff & Rs. 10000/- for General Public as Earnest Money Deposit (EMD drawn in the favour of Central Bank of India, Regional Office, Vadodara envelope should be scribed ~"BID FOR AUCTION OF VEHICLE".
3. Application fee is Rs. 500/- (Non-refundable). Application form will be available at Regional Office and could be downloaded from web-site as may be required. However, in case the application form is downloaded, the application fee (DD for the amount Rs. 500/-) and DD for EMD amount should be submitted by separate DD alongwith bid.
4. EMD of unsuccessful bidder will be returned.
5. Bid should be sent to the address : Regional Office, First Floor, BSNL Building, Opp: Jail Road, Near Kuber Bhavan, Vadodara - 390 001.
6. Last Date for receiving of bid is 16/08/2024, 17.00 hrs. Tender shall be opened by a Committee comprising of at least three officers headed by a Chief Manager (DRM) on 17/08/2024 at 11.00 hrs at Regional Office or any further date as per convenient of the Bank.
7. BID without Application Fee & EMD will be rejected.
8. Highest bidder (H1) will have to deposit remaining amount within 7 days could be considered by the Management only as an exception and in genuine cases.
9. In case of no response from H1 bidder, the EMD deposited by the highest bidder shall be forfeited and offer extended to H2 (H2 to match the rate of H1). Similar procedure shall be followed in respect of H2/H3 etc. till the Bank is able to get the "Reserve Price".
10. The vehicle shall be handed over to the buyer only after it is registered in the name of the buyer by RTO and documents to this effect are obtained. All charges for transfer of the vehicles will be borne by the purchaser.
11. Bank reserve the right for cancellation of auction process at any time.
