In case of no response from H1 bidder or if the H1 bidder refuses to accept the vehicle due to any reason, the EMD shall be forfeited, and the offer will be extended to the H2 bidder (H2 to match the rate of H1). Similar procedure shall be followed in respect of H3, H4, etc., if the Bank is able to get a price above the Reserve Price. **Vehicle shall not be disposed off below the Reserve Price. 14. The sold vehicle shall have to be removed by the successful bidder at his own expense.
15. The successful bidder will be responsible for getting the Registration Certificate of the vehicle transferred in his name and at his cost expeditiously. A photocopy of the RC & related documents should be given to the Bank before taking possession of the vehicle.
16. Approval of the sale offer is subject to the Bank's internal procedure and as such participating bidders have no right to claim interest on the Earnest Money deposited by them with the bid/quotation/sale offers.
17. The Bidder must sign each page of all the offer papers being submitted.
