After Registration by the bidder in the Web Portal, the intending bidder/ purchaser is required to get the copies of the following documents uploaded in the Web Portal before last date of submission of the bid viz. i) Copy of the NEFT/RTGS Challan; ii) Copy of PAN Card; iii) Proof of Identification (KYC) viz. self-attested copy of Voter ID Card/ Driving License/ Passport etc. iv) Copy of proof of address; without which the bid is liable to be rejected.

The interested bidders, who have submitted their bid not below the Reserve Price through online mode before **4:00 PM on 28.02.2020 & 16.03.2020** shall be eligible for participating the e-bidding process.
