- 7. The auction will be held on 23.12.2019 from 11.00 AM to 01.00 PM. There will be Inter-se Bidding and Bidder can improve their Bid Amount as per the Bid Increase Amount i.e. Rs. 10,00,000/- or its multiple and in case bid is placed during the last 5 minutes of the closing time of the e-Auction, the closing time will automatically get extended for 5 minutes (each time till the closure of e-Auction process), otherwise, it will automatically get closed.
