Terms and condition for E-Auction

The auction will be "Online E-auction" through **e-bkray portal**

- 1. Date and Time for auction: 05.07.2025 between 04:00 PM To 05.00 PM (With auto extension clauses in case of bid in last 5 minutes before closing). E-Auction is being held on "As is where is". "As is what is" and "Whatever there is" basis.
- **2.** Auction/Bidding shall only through "Online Electronic Bidding" through the website / portal e-bkray and property details is also available at e-bkray. Bidders are advised to go through the website for detailed terms and part in the e-auction sale proceedings.
- 3. Bidders has to complete following formalities well in advance:-
 - Step 1- **Bidder/ Purchaser Registration:** Bidder to register on e-Auction portal <u>e-bkray- PSB Alliance</u> using his mobile number and email-id.
 - Step 2: **KYC Verification:** Bidder to upload requisite KYC documents. KYC documents shall be verified by e-auction service provider (may take 2 working days)
 - Step 3: **Transfer of EMD amount to his Global EMD Wallet:** Online/ off-line transfer of fund using NEFT/Transfer, using challan generated on e-Auction portal.
 - Step 1 to Step 3 should be completed by bidder well in advance, before e-Auction date.
- 4. Earnest Money Deposit (EMD) as mentioned above shall be paid online through NEFT/RTGS Transfer in bidders Global EMD Wallet.
- 5. The successful bidder shall have to deposit 25% (twenty five per cent) of the bid amount, less EMD amount deposited, latest by the next working day and the remaining amount shall be paid within 15 days from the date of auction through NEFT/RTGS in the following account:-

Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders/Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet. Only after having sufficient EMD in his wallet, the interested bidder will be able to bid on the date of e-auction.
- **15.** Bidder's Global Wallet should have sufficient balance (>= EMD amount) at the time of bidding.
- **16.** Intending bidders are advised to properly read the Sale Notice, Terms & conditions of e-auction, Help Manual on operational part of e-Auction and follow them strictly.
