The Sale under Private Treaty will be conducted on the terms and conditions mentioned herein below:

- a) The Sale under Private Treaty will be conducted on or after 30.09.2024.
- b) Reserve Price of the property is Rs. 68,00,00,000/- (Rupees Sixty eight Crores). The property will not be sold below Reserve Price.
- c) The property will be sold on "As is Where is Basis", "As Is What Is Basis", and "Whatever There is Basis" and "Without Recourse" basis.
- d) An offer to purchase the property may be submitted to the Authorised Officer by any interested/ intending purchaser. Such offer shall be submitted with 10% of the offered amount as offer amount/ refundable deposit. The said amount shall be kept in non-interest bearing account.
- e) After submission of offer together with refundable deposit, the Intending Purchaser may conduct due diligence exercise regarding the encumbrance, charge and statutory outstanding of the secured asset under sale and should satisfy themselves about the title, extent of the mortgaged property and property under sale before submitting their offer. No claim of whatsoever nature regarding the title, charges and encumbrances over the mortgaged property etc. will be entertained after submission of the offer and at any stage thereafter and the successful purchaser shall have no claim regarding refund of amount deposited by him/her/it after being declared as successful purchaser.
- f) The intending purchaser shall complete its Due Diligence exercise before 27.09.2024 days and confirm its offer. The offer amount shall be kept in non interest bearing account.
- g) After due diligence exercise duly conducted, the Intending Purchaser may either confirm its offer or withdraw the same.
- h) If the intending purchaser withdraws its offer the offer amount will be refunded to it within a period of seven business days from the date of receipt of the communication of the Intending purchaser about such withdrawal.
- i) If the intending purchaser confirms its offer, Bank will consider the offer and will inform to the intending purchaser whether the offer is acceptable to the Bank or not.







- j) If the Bank accepts the offer of the Intending Purchaser, 25% of the purchase consideration shall be deposited by the intending purchaser within the next working day of receipt of Bank's communication of acceptance. The offer amount/ refundable deposit already deposited shall be adjusted to the said 25% of purchase consideration.
- k) The Intending Purchaser will be required to deposit the remaining 75% amount of the purchase consideration within 15 days from the date of receipt of Bank's communication of acceptance or within such extended time as may be granted by the Authorised officer in accordance with the provisions of the SARFAESI Act.
- 1) In case Bank / Authorised Officer receives more than one offer, the Bank will accept the highest offer. If the highest bidder fails to deposit the remaining amount as per the terms mentioned herein, then the bank may accept the next offer close to the highest offer.
- m) If after acceptance of the offer by the Authorised Officer/ Bank, the intending purchaser fails to deposit the amount as stipulated above, Authorised Officer/ Bank shall forfeit the amount already paid/deposited by such intending purchaser, where upon the intending purchaser shall not have any claim in any manner whatsoever.
- n) In case of non-acceptance of offer of purchase by the Bank, the offer amount already deposited will be refunded to the intending purchaser without any interest.
- o) On deposit of the entire consideration amount, the Authorised Officer will issue Sale Certificate to the Intending Purchaser.
- p) Upon issuance of sale certificate, the Intending purchaser shall arrange for the registration of Sale Certificate at its own cost and the Authorised officer of Bank will extend cooperation for execution and registration of the Sale Certificate and Deed.
- q) The intending purchaser shall bear the stamp duty charges including those of sale certificate registration charges. Any taxes, charges accrued on the Property under Sale after the date of sale shall be borne by the intending purchaser. However, the Vendor Bank will pay and clear all the tax dues to be paid to Bruhath Bangaluru Mahanagar Palike accrued till the date of issuance of Sale Certificate. Any taxes, charges accrued on the Property under Sale after the date of sale shall be borne by the intending purchaser. As
